When an employee grievance prevails, the lower level supervisors that were involved in the dispute may be temporarily prohibited from promotion. less than double of the damages.

The LHWCA prohibits an employer from discharging or otherwise discriminating against an employee who claims or attempts to claim compensation from the employer, or testifies or is about to testify against the employer in a proceeding under the statute.
